The Co-Chair called the meeting to order at 2:00 p.m. and confirmed quorum.

1. Approval of the Agenda

2. Remarks of the Co-Chair

The Co-Chair welcomed all members and introduced Paul Mains as the new Academic Co-Chair of the Committee and noted that Robin Yates, will be assuming the role of the Interim Dean and Vice-Provost (Graduate Studies) and the role of the Co-Chair, effective February 1, 2019.

The Co-Chair noted that this was her last meeting, and conveyed her gratitude to the Committee for ensuring the thoughtful and careful review of all proposals. The Chair further remarked that the Committee has been successful in meeting its mandate and this has enabled tremendous innovation and change within graduate programming at the University.

The Academic Co-Chair made no remarks.

3. Approval of the November 21, 2018 Meeting Minutes

4. <u>Approval of Calendar Changes: Faculty of Nursing: New Graduate Certificates and Master of Nursing</u> Pathway

Documentation for this item was circulated with the Agenda. Tanya Zdorenko and Lisa Young presented this item.

Highlights:

 The Committee discussed the proposed Calendar changes that were presented for the Faculty of Nursing and noted that pertinent information was lacking within the proposal and that further clarification from the Faculty is required. The Committee agreed that amendments would be required and that this item would be withdrawn and brought back to a future meeting.

5. <u>Approval of the Changes to the Program Requirements for the Werklund School of Education</u> <u>Approval of the Changes to the Admission Requirements for the Haskayne School of Business</u>

Documentation for this item was circulated with the Agenda. Tanya Zdorenko and Lisa Young presented this item.

Highlights:

- The Committee reviewed the proposed changes for the program requirements for the Werklund School of Education (WSE) and the admission requirements for the Haskayne School of Business (HSB) and noted that the proposed changes had been reviewed and recommended by the GAPS Calendar Working Group
- The Committee learned that the changes for the HSB reflect the acceptance of the Graduate Management Admission Council (GMAC) Executive Assessment for admission to the Executive Master of Business Administration program as an alternative to the Graduate Management Admission Test (GMAT) and that the minimum GMAC score aligns with the current GMAT requirement
- It was noted that the changes for the WSE in the Master of Education (MEd) Specialization route and the MEd Interdisciplinary route reflect that one of the elective courses be changed to a core required course
- The GAPS reviewed and approved the proposed changes for the WSE and the HSB programs and noted that the changes will be implemented in the 2019-2020 Graduate Calendar

6. Recommendation of the Revisions to the Graduate Calendar Academic Regulations regarding Academic Appeals

Documentation for this item was circulated with the Agenda. Andrea Klaiber-Langen and Cherie Tutt presented this item.

Highlights:

- The proponents outlined the background and rationale for the proposed revisions and it was noted that the changes to the University Calendar were reviewed and approved by the Academic Planning and Priorities Committee in December 2018. It was reported that the changes are being proposed to enable a more streamlined process, ensure consistency across the University and Graduate Calendars and to align with the Student Misconduct and Academic Appeals Policy and Procedures, that came into effect on January 1, 2019.
- The Committee reviewed the proposed revisions and expressed satisfaction with the changes and the extent of flexibility the amendments will provide and recommended the proposal move forward to the Academic Planning and Priorities Committee for approval

That the Graduate Academic Program Subcommittee recommend that the Academic Planning and Priorities Committee approve the revisions to the Academic Regulations in the Graduate Calendar regarding Academic Appeals as set out in the document provided to the Committee.

7. Recommendation of the Creation of a Stackable Certificate and Diploma in Leadership in Engineering and Advanced Practice

Documentation for this item was circulated with the Agenda. Gopal Achari presented this item.

Highlights:

- The proponent outlined the background and rationale for the creation of a Stackable Certificate and Diploma in Leadership in Engineering and Advanced Practice (LEAP) and reported that the Schulich School of Engineering (SSE) offers several programs, designed for full-time students, at the graduate level and a gap has been identified within its graduate offerings. It was noted that the LEAP program will form the basis of a broader initiative to create a laddered graduate certificate, diploma, and eventually a Master's degree program within LEAP to fill this gap.
- In response to questions, the proponents explained that:
 - The proposed courses are new and while there may be some overlapping content with existing courses, the intent for the programming is to enable the examination of emerging technologies and approaches to modern technical and societal problems

- Delivery options are being explored and will consist of either a blended or an online format, which will be contingent on the initial interest expressed through course enrolment. This will also provide a gauge of the necessary staffing requirements.
- The Committee discussed the proposed enrolment, the programming requirements, the
 consultation process and the rationale for the creation, noting the importance for practicing
 engineers to have the ability to further develop both their advanced engineering technical
 expertise as well as their leadership and professional skillset in order to progress in their careers
- The Committee provided the proponents with some suggestions to strengthen the proposal to
 include a statement in the admissions requirements to reflect that students must meet the GPA
 of the home department, to clearly state the final goal of the Master's program ensuring that the
 rationale of the program is clear to the Government of Alberta and to also signal the possibility of
 the designation as an Executive program
- The GAPS recommended that the proposal move forward to APPC for approval

That the Graduate Academic Program Subcommittee recommend that the Academic Planning and Priorities Committee approve the creation of a Graduate Certificate in Leadership in Engineering and Advanced Practice and a Graduate Diploma in Leadership in Engineering and Advanced Practice, as set out in the proposal provided to the Committee, with the requested amendments.

8. Recommendation of the Curriculum and Calendar Changes for the Post-Doctoral Diploma in Radiation Oncology Physics

Documentation for this item was circulated with the Agenda. Michael Roumeliotis presented this item.

Highlights:

- The proponent outlined the background and rationale for the curriculum and calendar changes
 for the Post-Doctoral Diploma in Radiation Oncology Physics and reported that to continue to
 meet the requirements of the Commission on Accreditation of Medical Physics Education
 programs and to align with the University of Calgary's Credit Certificate and Diploma Framework
 two business course requirements are being removed from the program
- The proponent reported that the curriculum changes resulting in a reduction of the total course requirements in the Post-doctoral Diploma in Radiation Oncology Physics (PDROP) from 24 units to 18 units
- The Committee learned that amendments to the proposed calendar changes are necessary and that these changes will be brought forward at the next GAPS meeting
- There were no questions
